#### Goals for Prioritization

- 1) Prioritize our region's top health concerns to be included in our Regional Public Health Plan
  - 2) Use a matrix of questions and voting process.
- 3) Informed by data, community engagement (significance), ability to impact (evidence-based strategies) and capacity
  - 4) Consider whether it was a past priority and if there is regional consensus

### Prioritization Matrix

From 2021 to 2023 West Central Public Health Partnership (WCPHP) conducted a regional capacity assessment and a community health assessment to identify the top issues affecting the community.

The community health assessment included gathering secondary data, collecting survey responses, and conducting key informant interviews.

To determine the upcoming public health improvement plan priorities, WCPHP utilized the Colorado Health Assessment & Planning System Prioritization Scoring Tool.

#### Prioritization Goals

The WCPHP Steering Committee (local public health directors) agreed on goals for the prioritization that included:

Firstly, capping the priorities to no more than three, in order to focus in on the strategies and plan.

Secondly, for one of the goals to be Environmental Health focused, or for all of the goals to integrate an Environmental Health strategy.

Lastly, there would be Regional Capacity for each chosen priority.

#### Prioritization Criteria

The region's public health directors, Regional Epidemiologist, Gunnison Clinical Services Supervisor, Delta Environmental Health Director, San Miguel Health Educator, and Delta Outreach Specialist participated in the voting process.

Each criteria question was reviewed for understanding and agreement. All criteria were kept as is, but, a Regional Consensus question was added, "Is this a top priority for your county?" to confirm that each public health director was providing agreement or disagreement that a specific issue was a priority for their respective county.

Each of the criterion were weighted as-is, with no weight added, except for the Regional Consensus criterion was weighted double.

The process was facilitated by the WCPHP Coordinator and the WCPHP Grants Coordinator. Notes were collated and can be found throughout this presentation.





#### **Updated list of Issues prior to ranking**

WCPHP reviewed the list of evidence-based strategies, and some examples of current efforts throughout the region meant to improve the issues.

The public health directors were given the opportunity to pitch either adding or removing an issue.

WCPHP agreed that Affordable Housing, Affordability of Care, and Transportation are traditionally not in the perceived realm of public health and that other entities or organizations have capabilities to make a bigger impact and can more successfully take a lead on improving these issues.

Environmental Justice was added as an issue per the WCPHP Intergovernmental Agreement requirements to include an Environmental Health priority, and the continuous need for improvement.

Affordable housing, Affordability of Care, and Transportation were removed.

Environmental Justice was added.

## Prioritization Matrix Methodology

WCPHP used a Google form to rank each of the seven (7) issues against each of the seven (7) criteria. The possible responses for each question were:

0 = No

1 = Somewhat

2 = Yes

The Regional Consensus section of the form was for the public health directors only. This section asked if each of the issues was a top priority for the public health director's respective county.

Once all responses were collated, WCPHP staff tallied the totals for each issue and criteria question, and assigned the appropriate weights to each criterion. Regional Consensus was weighted doubly.

## Health Equity Framework & Priority Populations

Through the Community Health Assessment key informant interviews, priority populations were identified:

- Seniors
- Immigrants and non-English speakers
- LGBTQ+
- Children
- Homeless
- Low income

WCPHP will continue to ground the conversation for the Public Health Improvement Plan using the Health Equity Framework to "address the social determinants of health through healthy public policy to achieve health equity among all Coloradans." (Health Equity Framework - CDPHE - Social Determinants of Health Workgroup (2010)).
